## 1. Net Position Review

Marcus Beverly reported that MERMA's financial position is reviewed annually. The Funding Policy states that the Program Manager will present how MERMA is doing compared to the Funding Policy benchmarks. This is presented at the Board Meeting in October. He stated this is a preview to see if the Executive Committee would like to make any recommendations as part of the review of the Funding Policy. MERMA passed an accompanying Dividend Policy which spells out how to allocate dividends or assessments among the members should those be declared.

Rory Livingston called in to the teleconference at 1:45 p.m.

Marcus presented a "Draft" Balance Sheet and Profit and Loss Statements received from MERMA's accountant along with a PowerPoint Funding Policy Analysis. He stated MERMA is above the goals on every benchmark. This leaves members with options that include smoothing of premiums and funding of special risk management projects.

After lengthy discussion, no action was taken on this item. The Committee gave guidance to the Program Managers to provide different options and recommendations to present at the October 9<sup>th</sup> Board of Directors Meeting.

# 2. Matching Safety Funds Update FY 2018-19

Marcus Beverly provided an update on the Matching Safety Funds usage for FY 2018-19 with 83% (\$66,032.98) of the allocated funds used. There were five districts that did not use any of their funds. Discussion held as to why some districts do not use their funds.

# 3. Topics for the October Board Meeting

Marcus Beverly presented the "Draft" agenda for the October 9<sup>th</sup> Board of Directors Meeting for the Committee's review and discussion.

Veronica Flournoy thanked Marcus Beverly and Matt Gowan for guiding us through all of the past years and helping get to this positive position that we are in. She stated it's nice to be able to talk about things such as investing in projects.
