Marcus Beverly presented Bickmore's Actuarial Review of the Workers' Compensation Program. MERMA's outstanding liabilities as of June 30, 2022 are projected to decrease by almost \$1.5 million (-9%). This is due to favorable loss development across most historical years.

# 2. Workers' Compensation Excess Insurance Proposal FY 2022-23

Matt Gowan presented the Workers' Compensation Excess Insurance Proposal for FY 2022-23. The Executive Committee reviewed the proposal at the last meeting and recommended renewing at the \$50,000 Self-Insured Retention. He stated this proposal indication is almost \$200,000 less than previously reviewed.

Motion was made to approve the renewal of the Workers' Compensation Excess Insurance Proposal for FY 2022-23 with a Self-Insured Retention of \$50,000. The first layer of Excess \$50,000-\$500,000 with State National and the second layer \$500,000-Statuatory with Safety National.
